
1. Performance Target

- 1.1. The target for this Event is to provide a positive competitive opportunity in the long-term development of British junior swimmers towards future senior international success, whilst at the same time maximising the medal outcomes in Olympic individual and Olympic relay events.

2. Selection Trials

- 2.1. Selections will be made from performances at the British Championships/Olympic Trials, Tollcross, Glasgow from 12th – 17th April 2016 ('the Trials') only, subject to Clause 5.2.

3. Team Size

- 3.1. Up to a maximum of 26 swimmers may be selected, subject to available funding. The total number of swimmers selected will be at the complete discretion of the Head of Performance Pathway.
- 3.2. Up to two (2) places will be available in each individual Olympic event. However, where LEN permits up to four (4) entries in an individual event, the Head of Performance Pathway may use his complete discretion to fill the 3rd and 4th spot from any swimmers selected under clauses 5.1 and 5.2.
- 3.3. If the number of eligible qualifying athletes identified in clause 5.1 exceeds the maximum number of available places, swimmers will be selected at the complete discretion of the Head of Performance Pathway in consultation with the GB Head Coach.
- 3.4. If the number of eligible qualifying athletes identified in clause 5.1 plus the additional six wildcard places outlined in 5.2 is less than the maximum number of available places, the Head of Performance Pathway may increase the number of 'wildcard' places at his absolute discretion, always subject to Clause 3.1.

4. Age Eligibility

- 4.1. Boys born 1998 / 1999 / 2000 / 2001
- 4.2. Girls born 1999 / 2000 / 2001 / 2002

5. Individual Event Selection

- 5.1. To be eligible for selection for an individual event, a swimmer must have recorded a time that equals or betters the Minimum Consideration Times set out in Table 1 at 'the Trials'. The achievement of a Minimum Consideration Time does not mean the swimmer has achieved automatic selection and does not guarantee selection.
- 5.2. Up to six (6) wildcard places on the final team may be filled, at the complete discretion of the Head of Performance Pathway in consultation with the GB Head Coach. These selections can be made from swimmers who have not have achieved the Minimum Consideration Times listed in Table 1 at the Trials, or from swimmers not competing the Trials, who are deemed to be able to contribute to the Performance Target set out in Clause 1.1. The Head of Performance Pathway is under no obligation to use these wildcard places.
- 5.3. All performances recorded in all rounds at 'the Trials' will be taken into account.

- 5.4. Entry into non-Olympic events will be limited to those swimmers who have already been selected for the Team under Clauses 5.1 and 5.2, and will be at the complete discretion of the Head of Performance Pathway.
- 5.5. The Head of Performance Pathway reserves the right to withdraw any athlete selected for this Event if the athlete is selected for the 2016 Olympic Games or 2016 European Championships, in consultation with the athletes' coach and GB Head Coach. In the event of a withdrawal any replacement athlete may be selected at the complete discretion of the Head of Performance Pathway in consultation with the GB Head Coach. There is no obligation on the Head of Performance Pathway to select a replacement.

6. Relay Event Selections

- 6.1. All team members selected under clauses 5.1 and 5.2 for individual events will be considered to be eligible for relay team selection.
- 6.2. Additional swimmers may be selected for the relay events at the complete discretion of the Head of Performance Pathway.

7. Announcement

- 7.1 The 2016 European Junior Championship Team will be announced on Friday 29th April 2016.

SELECTION POLICY GENERAL CONDITIONS

Eligibility

Athletes must:

- G1 Be a British citizen and eligible to represent Great Britain as per the FINA General Rule 2 (GR 2).
- G2 Have completed a Selection Acceptance Form to confirm they will be available to participate. Failure to do so will be interpreted as non-availability by British Swimming. Selection Acceptance Forms will be provided by British Swimming to qualifying team members.
- G3 Be available to fulfill national team commitments.

Team Commitments

All Team members will be required to:

- G4 Comply with the British Swimming Code Of Conduct. A breach of the British Swimming Code of Conduct may result in de-selection from the team.
- G5 Abide by media protocols of the British Swimming Programme. Athletes must only speak to the media about their own performances and group coaches must only comment on performances of swimmers in their group. The GB Head Coach and National Performance Director may discuss performances of the entire team.
- G6 Not take holiday or attend overseas camps and/or competitions between the selection trials and the meet for which they have been selected without prior written approval from the National Performance Director.
- G7 Make themselves available for all team activities designated by the GB Head Coach (including but not limited to preparation camps and staging camps). No team member will be allowed to leave a national team camp or undertake any activities that are not directly relevant to the team camp programme, this includes any external media, sponsor or social activities. Failure to attend the required activities could result in withdrawal from the team. Under exceptional circumstances, written approval to be excluded from activities may be given by the National Performance Director.
- G8 Comply with British Swimming and FINA swimwear regulations.

Withdrawals

- G9 If for any reason an athlete is unable or unwilling to fully comply with the Team Commitments (G6 to G10) they may be withdrawn from the team.
- G10 Athletes becoming unfit due to illness or injury at any time following their selection must notify British Swimming immediately and will be required to undertake a full medical examination by British Swimming Medical staff, which may result in the athlete being de-selected from the team at the complete discretion of the GB Head Coach.
- G11 Athletes may be subjected to fitness (land/water) and/or medical tests at any time following their selection. Any athlete judged to be unfit by British Swimming, following tests conducted by British Swimming, may be de-selected from the team at the complete discretion of the GB Head Coach.

Replacements

- G12 Replacement of athletes withdrawn from the team will be considered at the complete discretion of the GB Head Coach if viewed to be in the best interest of the overall team performance, subject to clause 5.5.

Other

- G13 The World Class Programme Performance Leadership Group (PLG) may amend selection policies at any time at its discretion.

Appeals

- G14 Any appeals against selections in relation to selection policies must be made in accordance with the British Swimming Team Selection Appeals Procedures, available by request from Adam Clarke, Head of Performance Services via email at adam.clarke@swimming.org. Athletes should be aware of the time limits contained in the Procedures, which are designed with the intention of resolving issues expeditiously and fairly.
