



2024 WORLD CHAMPIONSHIPS 2nd – 10th February 2024, Doha, QATAR

DIVING SELECTION POLICY

1 POLICY PURPOSE

1.1 This Selection Policy outlines the process for selecting the Diving team to represent Great Britain at the 2024 World Championships in Doha, Qatar 2nd – 10th February 2024.

2 PERFORMANCE OBJECTIVE

- 2.1 The objective for this event is to maximise medal opportunities in Olympic events and to qualify any remaining athlete quota places for the Paris 2024 Olympic Games. Team GB can still obtain additional quota places in the following Olympic events:
 - 2.1i Men's 3m Individual 1 place
 - 2.1ii Women's 3m Individual 1 place
 - 2.1iii Men's 10m Synchro 1 team place

3 SELECTION OVERVIEW

- 3.1 All selections with be made by a Selection Panel (the "Panel") comprising three (3) members. The Selection Panel members are: the British Swimming Performance Director, Associate Performance Director, and Head Coach Olympic Diving, with a record of the Selection Meeting taken by a note taker.
- 3.2 An Independent Observer will also attend the Selection Meeting to ensure due process, but with no voting rights.
- 3.3 Selections will be made from performances at the 'Scottish National Diving Championships incorporating the British Diving National Cup 2023', Royal Commonwealth Pool, Edinburgh, 14th 17th December 2023, (known as "the Selection Event"), subject to clause 5 below.
- 3.4 In the event that the Selection Event is cancelled, a revised selection policy will be published by the Diving Leadership Team.

4 TEAM SIZE

- 4.1 World Aquatics makes provision that each National Federation may enter a maximum of two (2) competitors per event for each individual event and one (1) team of two (2) competitors for each synchronised and mixed diving event.
- 4.2 The total number of divers selected for the 2024 World Championships will be at the complete discretion of the Associate Performance Director, and subject to available funding.
- 4.3 The split of places by gender will be at the complete discretion of the Panel.
- 4.4 Priority will be given to selecting athletes in the Olympic events and specifically events listed in clause 2.1 where remaining quota places still need to be obtained. There is no requirement for non-Olympic events places to be utilised.





4.5 Divers based overseas (outside of the United Kingdom) should take specific note of the General Conditions of this policy, with specific reference to clauses G3, G7 and G8.

5 SELECTION PROCESS

- 5.1 In the Olympic Individual events outlined in clause 2.1, the highest placed diver at the Selection Event who hasn't already secured a Team GB quota place will be selected for the 2024 World Championships, subject to achieving the Qualifying Standards set out in Table 1 in both the Preliminary and Final rounds.
- 5.2 In the Olympic Individual events outlined in clause 2.1, any remaining unallocated places will also be selected at the complete discretion of the Panel from divers who haven't already secured a Team GB quota place.
- 5.3 For all remaining Olympic Individual events (those not listed in clause 2.1), the highest placed diver at the Selection Event will be selected for the World Championships, subject to achieving the Qualifying Standards set out in Table 1 in both the Preliminary and Final rounds.
- 5.4 Any additional unallocated places remaining in the Olympic individual events (those not listed in clause 2.1) may be selected at the complete discretion of the Panel.
- 5.5 For the Olympic Synchronised teams, divers will be selected by the Panel.
- 5.6 For all non-Olympic events, divers may be selected by the Panel at their complete discretion, subject to clauses 4.2 and 4.4.

6 EVENT ENTRIES

6.1 This policy selects divers onto the 2024 World Championship Team. The Head Coach Olympic Diving in consultation with the Associate Performance Director has the responsibility to then determine all final event entries.

7 ANNOUNCEMENT

7.1 The 2024 World Championships Team will be formally announced on or before 19th December 2023.

SELECTION POLICY GENERAL CONDITIONS

Eligibility

Athletes must:

- G1 Be a British citizen and eligible to represent Great Britain as per the World Aquatics General Rule 2 (GR 2).
- G2 Have completed a Selection Acceptance Form to confirm they will be available to participate. Failure to do so will be interpreted as non-availability by British Swimming. Selection Acceptance Forms will be provided by British Swimming to qualifying team members.
- G3 Be available to fulfil all team commitments.
- G4 Comply with any other World Aquatics eligibility criteria from time to time, including in respect of nationality and/or anti-doping.

Team Commitments

All Team members will be required to:

- G5 Comply with the British Swimming Code of Conduct. A breach of the British Swimming Code of Conduct may result in de-selection from the team.
- G6 Abide by media protocols of the British Diving Programme. Divers must only speak to the media about their own performances. The Head Coach Olympic Diving and event Team Leader may discuss performances of the entire team.
- G7 Not take holiday or attend overseas camps and/or competitions between the Selection Event and the meet for which they have been selected without prior written approval from the Head Coach Olympic Diving.
- G8 Make themselves available for all team activities designated by the Head Coach Olympic Diving (including but not limited to preparation camps and staging camps). No team member will be allowed to leave a national team camp or undertake any activities that are not directly relevant to the team camp programme, this includes any external media, sponsor or social activities. Failure to attend the required activities could result in withdrawal from the team. Under exceptional circumstances, written approval to be excluded from activities may be given by the Head Coach Olympic Diving.
- G9 Comply with British Swimming and World Aquatics swimwear regulations 2024 World Championships.





Withdrawals

- G10 If for any reason an athlete is unable or unwilling to fully comply with the Team Commitments (G5 to G9) they may be withdrawn from the team.
- G11 Divers becoming unfit due to illness or injury (physical or mental) at any time following their selection must notify British Swimming immediately and will be required to undertake a full medical examination which may result in the swimmer being de-selected from the team at the complete discretion of the Head Coach Olympic Diving. In the event of injury or illness athletes may be deselected if they pose a risk to themselves, other athletes or team staff as determined by the British Swimming Chief Medical Officer or their designate.

Replacements

G12 Replacement of athletes withdrawn from the team will be considered at the complete discretion of the Head Coach Olympic Diving if viewed to be in the best interest of the overall team performance, subject to clause 4.1.

Other

G13 The Diving Leadership Team may amend selection policies at any time at its discretion.

Appeals
